

Food Vendor/Concessionaire Application

Sunday, October 9, 2016 10:00 AM – 6:00 PM

The 22nd Annual Little Italy FESTA is open to artists, Italian and non-Italian art, craft vendors, and food vendors. The Little Italy FESTA is an Italian cultural event with two stages of entertainment, Gesso Italiano (chalk painting exhibition), stickball tournament and children's area. Over 120,000 attended this event last year in the Little Italy neighborhood of downtown San Diego. Space is limited. Register early!

Early Registration Deadline: September 6, 2016 or until spaces are filled. No walk-on vendors will be accepted.

Late Registration Fees: After September 6, 2016 add \$50.00.

Event Hours and Set Up: Sunday, October 9 from 10:00 am to 6:00 pm. Set up is between 6 am and 8:30 am. Vehicles will be allowed

to drive onto India Street to unload merchandise. You may not begin assembling your booth until after your vehicle has been removed from the street. All vehicles must be removed from the street by 8:30 am. Cars will

not be allowed back onto the street until the close of the event. No early departures.

Parking Parking information will be sent 30 days prior to event.

Review Process: Due to space restrictions, space assignments are made on a first come, first serve basis and will go through a

review process for acceptance or denial. All vendors are subject to review and receipt of application does not guarantee a space. The Association reserves the right to refuse space to anyone. Photos of your booth and

items sold are required by all vendors. You will be notified within 2 weeks if you have been approved.

Concessionaires: Examples of concessionaires include: snack food items such as biscotti by the piece, pre-made cannolis, nuts,

pre-packaged popcorn/ kettle corn, factory produced and packaged food items (no on site preparation).

Space Assignments: The Association will place all vendors. You may request a space on your application but there are no

guarantees. Vendors will receive a space assignment number and map by October 1st. After you receive your

assignment please do not call the office to change your placement.

Sales Information: The Little Italy Association reserves the right to determine if a business, organization or activity is suitable for the

Little Italy FESTA. Please list all items that you will be selling on the application. The Association reserves the

right to request removal of items that are not listed on the pre-approved vendor application.

Health Permits: All food vendors/concessionaires must have current and up to date San Diego County Health Permits, business

licenses and Certificates of Insurance. Copies of these permits are required with your application or your application will not be accepted. Please call San Diego County Health Department at 619-338-2363, if you have

any questions. Please describe all food items to be sold on the application.

Fees: Fees vary upon space size and are non-refundable. Please make checks or money order payable to: Little

Italy FESTA San Diego. All fees must be included with your application in order to be approved.

Sales Tax: Vendors must submit a copy of your valid California Sellers Permit (state sales tax license) with application.

Vendors are responsible for collecting and reporting sales tax.

Electrical: Electrical power will be available for all vendors at an additional cost of \$75.00 and fees must be included with

your vendor application. You will be required to supply a plug or UL adapter to match, plus 100 feet of heavy duty cord. Each vendor is responsible for taping down their own cords. The Little Italy Association electrical contractor will be assisting vendors with their hook ups and has the authority to remove any hook ups deemed to

be unsafe.

Clean Up: All vendors are responsible for cleaning up their booth space. Those vendors whose spaces are not returned to

original conditions will be denied entrance next year.
